Athens County Board of Elections
Regular Meeting
June 10, 2021, 3:30 pm

The Athens County Board of Elections met on June 10, 2021 at 3:30 pm at the Athens City Council Chambers. The meeting was called to order by Board Chair McGuckin, Roll Call – Sky Pettey, Aundrea S. Carpenter-Colvin, Gary Van Meter, Kate McGuckin all present. Also present at the meeting: Director Debbie Quivey, Deputy Director Tony Brooks, Secretary of State Regional Liaison Lori Baldrige, Beth Farrier, Debbie Perry and Helen King with the League of Women Voters.

Ms. McGuckin led the pledge.

Director Quivey spoke about the legal opinion from Athens County Assistant Prosecutor Kirk Shaw regarding the shielding of addresses for Athens County Children Services workers.

Director Quivey informed the Board that there was an email received concerning the residency of the current Coolville Mayor and a council member. This issue has been sent to Assistant Prosecutor Kirk Shaw for review and the results will be shared with the board at a later date.

Motion 2021:06:01

Mrs. Carpenter-Colvin moved, seconded by Mr. Van Meter to approved as presented by Director Quivey the staffing of polling locations for the August 3, 2021 Special Primary. Motion passed unanimously.

Motion 2021:06:02

Mr. Van Meter moved, seconded by Mr. Pettey to move York Township Precinct from the Church of the Nazarene to The Lodge at Hocking College due to the church property is listed for sale. Motion passed unanimously.

Led by Director Quivey the Board proofed ballots for the August 3, 2021 Special Primary Election.

Director Quivey reminded the Board about the Regional District meeting on July 23, 2021.

Motion 2021:06:03

Mr. Pettey moved, seconded by Mrs. Carpenter-Colvin to keep Buchtel Village Precinct at The Shop and to not move the precinct back to the Town Hall due to The Shop being ADA compliant and the Town Hall is not ADA Compliant. Motion passed unanimously.

A discussion was had by the board to keep having board meetings at the Athens City Council Chambers for as long as the room is available.

Deputy Director Brooks announced & presented the board with the commendation that the office had received from Secretary of State Frank LaRose and his staff at 2021 Summer Conference.

Mr. Van Meter moved, seconded by Mr. Pettey to keep Carthage Township Precinct at Federal Hocking Middle School with Rome Township and to not move the precinct back to the Carthage Township Fire Department due to the fire department not being ADA compliant, extra traffic and parking issues. There are fire trucks at the fire department now that were not there when it was being used as a polling location. Voting: Mrs. Carpenter-Colvin – Yes, Mr. Van Meter – Yes, Mr. Pettey – Yes, Ms. McGuckin – abstained from voting.

Mr. Pettey moved, seconded by Mrs. Carpenter-Colvin that the minutes for May 13, 2021, May 17, 2021 and May 19, 2021 be approved by the board as presented. Motion passed unanimously.


