

**Minutes**  
**Athens County Board of Elections**  
**Regular Meeting**  
**March 16, 2022, 3:30 pm**

The Athens County Board of Elections met on March 16, 2022 at 3:30 pm at the board office. The meeting was called to order by Board Chair McGuckin, Roll Call – Aundrea S. Carpenter-Colvin, Gary Van Meter, Sky Pettey and Kate McGuckin all present. Also present at the meeting: Director Debra Quivey, Deputy Director Tony Brooks, Parker Colvin, Beth Ferrier and Helen King from League of Women Voters.

Ms. McGuckin led the pledge.

Motion 2022:03:04

Mr. Van Meter moved, seconded by Mr. Pettey that the minutes for February 8, 2022 and March 9, 2022 be approved by the Board as presented. Motion passed unanimously.

Budget updates were provided and presented by Deputy Director Brooks.

Motion 2022:03:05 (Attachment 1)

Mrs. Carpenter-Colvin moved, seconded by Mr. Van Meter that bills from February 9, 2022 to March 16, 2022 be approved as presented by Deputy Director Brooks. Voting: Mrs. Carpenter-Colvin – Yes, Mr. Van Meter – Yes, Mr. Pettey – Yes, Ms. McGuckin – Yes

Motion 2022:03:06

Mr. Pettey moved, seconded by Mr. Van Meter to amend motion 2022:02:24 as follows: “Mr. Pettey moved and seconded by Mrs. Carpenter-Colvin to make it standard procedure to contact candidates that were not certified to the ballot as proposed by Director Quivey.” Motion passed unanimously.

Motion 2022:03:07

Mrs. Carpenter-Colvin moved, seconded by Mr. Pettey to allow the Director, Deputy Director and Board Office staff to process provisional ballots, according to Directive 2022-12 page 245, for the May 3, 2022 Primary Election. Motion passed unanimously.

Motion 2022:03:08

Mrs. Carpenter-Colvin moved, seconded by Mr. Pettey to allow the Director, Deputy Director and Board Members or their designee to approve infrequent and minimally valued expenditures for food/snacks/non-alcoholic drinks for election workers, poll workers and training in which the community is involved. for the May 3, 2022 Primary Election. Pursuant to IRS Reg 1.132-6 and IRS Reg 1.119-1 all expenses met the De Minimis Exclusion and/or Meals for the Convenience of the Employer and are excludable as taxable fringe. Voting: Mrs. Carpenter-Colvin – Yes, Mr. Van Meter – Yes, Mr. Pettey – Yes, Ms. McGuckin – Yes

Director Quivey presented that the new dates for UOCAVA is now April 5, 2022 and we will prepare them as soon as possible with the changes from the Secretary of State. Board was informed to be open for changes to scheduled meetings.

Director Quivey explained in office procedure on programming. Any office staff on the ballot will not be doing the programming. They will just be observing the programming. Any office staff on the ballot will not handle any ballots that their name appears on. They will get other office staff to handle those ballots.

Mr. Van Meter moved, seconded by Mr. Pettey to approve all poll workers for the May 3, 2022 Primary Election as presented by Director Quivey and Deputy Director Brooks. Motion passed unanimously.

Mr. Van Meter moved, seconded by Mr. Pettey to approve all extra elections workers for the May 3, 2022 Primary Election as presented by Director Quivey and Deputy Director Brooks. Motion passed unanimously with Mrs. Carpenter-Colvin abstaining from the vote.

Mr. Van Meter moved, seconded by Mr. Pettey to approve the first allocation of voting equipment for the May 3, 2022 Primary Election. Motion passed unanimously.

Deputy Director Brooks informed the Board that we have received and deposited \$58,544.00 grant money for May 3, 2022 Primary Election. Our office should be able to spend that money for any primary expenses. We are also expecting \$1,413.00 from the Secretary of State for expedited delivery and return of UOCAVA ballots.

Deputy Director Brooks informed the Board that he was contacted by Robert Pullins (Carthage Township Trustee) regarding the of moving of Carthage Township polling location back to the Carthage Township Fire Department. Mr. Pullins requested that someone from our office come and inspect changes and updates that have been made to the facility. Mrs. Carpenter-Colvin stated that she had stopped and looked at the exterior upgrades that have been made and provided photos that she and Parker Colvin had taken. Discussion was had regarding the road to the location, differences in the two locations, fire truck location and parking. The Board has agreed to table a decision at this time for an ADA assessment to be completed by Brett from Secretary of State.

Director Quivey informed the board that Assistant Prosecutor, Kirk Shaw will be leaving the Prosecutors Office.
