Athens County Board of Elections
Disputed Meeting
November 13, 2024, 5:00 pm

The Athens County Board of Elections met on November 13, 2024 at 5:00 pm at the Board Office. The meeting was called to order by Board Chair Pettey, Roll Call – Aundrea S. Carpenter-Colvin, Gary Van Meter, Sky Pettey and Kate McGuckin all present. Also present at the meeting: Director Debra Quivey, Deputy Director Tony Brooks, Lauren Dikis and Helen King from the League of Women Voters.

Mr. Pettey led the pledge.

Director Quivey provided an update regarding Absentee ballots that were returned after Election Day.

Motion 2024:11:03 (Attachment 1)

Ms. McGuckin moved, seconded by Mrs. Carpenter-Colvin to reject and not count the 1 absentee ballot that no signature was on the Identification Envelope as presented by Director Quivey. Motion passed unanimously.

Motion 2024:11:04 (Attachment 1)

Mrs. Carpenter-Colvin moved, seconded by Ms. McGuckin to reject and not count the 5 absentee ballots that were received with no stubs as presented by Director Quivey. Motion passed unanimously.

Mr. Van Meter moved, seconded by Mrs. Carpenter-Colvin to reject and not count the 10 absentee ballots that were received without an Identification Envelope as presented by Director Quivey. Motion passed unanimously.

Mrs. Carpenter-Colvin moved, seconded by Ms. McGuckin to reject and not count the 144 provisional ballots that were not registered anywhere in the State of Ohio as presented by Director Quivey. Motion passed unanimously.

Mrs. Carpenter-Colvin moved, seconded by Mr. Van Meter to reject and not count the 19 provisional ballots that failed to provide a current valid address as presented by Director Quivey. Motion passed unanimously.

Mrs. Carpenter-Colvin moved, seconded by Mr. Van Meter to accept and remake the 18 provisional ballots that were cast in the wrong precinct but right polling location as presented by Director Quivey. Motion passed unanimously.

Ms. McGuckin moved, seconded by Mr. Van Meter to reject and not count the 2 provisional ballots that were cast in the wrong polling location and wrong precinct as presented by Director Quivey. Motion passed unanimously.

Mrs. Carpenter-Colvin moved, seconded by Ms. McGuckin to reject and not count the 54 provisional ballots that failed to provide a valid photo ID by the 4th day after Election Day presented by Director Quivey. Motion passed unanimously.

Mr. Van Meter moved, seconded by Ms. McGuckin to reject and not count the 8 provisional ballots that failed to provide a correct date of birth on the provisional envelope as presented by Director Quivey. Motion passed unanimously.

Motion 2024:11:16 (Attachment 2)

Mrs. Carpenter-Colvin moved, seconded by Ms. McGuckin to reject, not count and refer to the Prosecutors Office for double voting the 2 provisional ballots were the Voters double voted as presented by Director Quivey. One, the voter requested and returned an absentee ballot in Franklin County and then voted a provisional ballot at the polling location on Election Day in Athens County. The other voted early in the Board Office and then voted a provisional ballot at their polling location on Election Day in Athens County. Motion passed unanimously.

Mr. Pettey moved, seconded by Ms. McGuckin to amend the agenda to include the printing error that caused an issue at the Athens County Community Cares Resource Center (Voting Location in Nelsonville) on Election Day. Motion passed unanimously.

Mr. Van Meter moved, seconded by Mrs. Carpenter-Colvin to accept and remake the 49 Election Day ballots that were cast and put in the emergency bin at Athens County Community Cares Resource Center (Voting Location in Nelsonville) because of a printing error as presented by Deputy Director Brooks. Motion passed unanimously.

Ms. McGuckin moved, seconded by Mrs. Carpenter-Colvin to accept and remake the 39 Election Day ballots that voters came back and cast a second page 2 to vote on Issue 23 at Athens County Community Cares Resource Center (Voting Location in Nelsonville) only because of a printing error as presented by Deputy Director Brooks. Motion passed unanimously.
