## REPORTING REQUIREMENTS

Please read the descriptions below to determine which category your candidacy falls under. Select the appropriate category by marking the line next to the number and sign at the bottom.

       **1. Designation of Treasurer (Form 30-D)**

Prior to receiving any contributions, or making any expenditure towards your election to office, you will need to file this form with the Board of Elections Office. The filing of campaign finance reports will be required. By not filing a form 30-D (Designation of Treasurer), a candidate indicates they will not receive or expend any funds...even their own...to influence the outcome of their election. See #3 Filing Fee Only Candidate.

       **2. Local Candidate Waiver (requires Form 30-D & Form 31-BB)**

A candidate's campaign committee may be exempt from the requirement to file campaign finance reports during an election year (except for the Form 30-D) if the candidate is running for:

1. An elected municipal office that pays an annual amount of \$5,000 or less.
2. A board of education office.
3. A township trustee or township fiscal officer.

In order to qualify for the Local Candidate Waiver, the candidate seeking election to any office listed above must file both Form 30-D (Designation of Treasurer) and Form 31-BB (Local Candidate Finance Report Waiver) within 10 days of filing a petition. The Form 31-BB requires the treasurer to agree that the campaign committee will not accept more than \$2,000 in aggregate contributions during the election period, no more than \$100 from any individual and not make expenditures totaling more than \$2,000. If the campaign committee exceeds any of these limitations, Form 31-BB is void and the campaign committee is thereafter responsible for filing all required reports including all activity occurring since the candidacy petition was filed. The \$100 per individual contribution restriction does not apply towards contributions made from the candidate's personal funds.

A campaign committee that qualifies for and operates under the conditions of the waiver is exempted from filing campaign finance reports, but is not exempt from keeping accurate records of all campaign finance activity which must be reserved for six years.

       **3. Filing Fee Only Candidate**

The payment of a filing fee by the candidate from the candidate's personal funds is not considered either a contribution or an expenditure that requires the filing of a Designation of Treasurer (30-D) form. Therefore, a candidate who receives no contributions and makes no expenditures, except for the filing fee paid from their own personal funds, is not required to file the (30-D) form to create a campaign committee and thus not subject to the reporting requirements. However, if the candidate files a Designation of Treasurer (30-D) form, the payment of a filing fee is a legitimate campaign expenditure that may be paid by campaign committee funds and reported as such.

## CANDIDATE FILING CHECKLIST

**Before filing your petitions carefully read, complete and sign the following checklist.  
Candidates are ultimately responsible for the correctness and sufficiency of their petitions.**

Employees of the Fulton County Board of Elections are prohibited from pre-checking petitions prior to the date of filing by Directive 2011-18 issued by the Secretary of State. Information on how to complete petitions is provided in the Secretary of State's Candidate Handbook and Frequently Asked Questions.

- Statement of candidacy:** Completed-including required unexpired term ending or full term commencing date (if applicable) and candidate signature dated **prior** to circulating the petition.
- Nonpartisan Candidate Committee Designation:** (Optional)
- Nominating Petition/Petition for Candidate:** Completed-including unexpired term ending or full term commencing date (if applicable).
- Petition Signers:** Complete addresses and dates are required of all signers. Sufficient quantity of valid signatures to qualify, but not more than 3 times the number required. If the district of the office you are filing for encompasses more than one county, a separate petition must be used for each county.
- Correct Dates:** Dates of all signers must be on or after the day the candidate signed the "Statement of Candidacy" and the unexpired term ending or full term commencing date must be completed (if applicable).
- Circulator Statement:** Completed- including correct number of signatures on petition, address and signature of person circulating petition (even if candidate circulates petition, this must be signed).
- Once a petition is submitted and time stamped, it is considered filed. No changes can be made or other action taken to alter its content. Acceptance of your filed petition by the Fulton County Board of Elections personnel, does not guarantee approval. Statutory authority to review each petition for compliance with Ohio Election Law and subsequent approval, is the responsibility of the members of the Board of Elections. Candidates are responsible for the accurate preparation and circulation of their petitions. Petitions may be withdrawn before the Board of Elections takes action to certify to the ballot, but may not be withdrawn after Board of Elections action.**

# FINANCIAL DISCLOSURE STATEMENT FILING NOTIFICATION FOR CANDIDATES RUNNING FOR OFFICE IN 2021

As a candidate in 2021 for any of the following elected offices, you are required by Ohio law to file a personal financial disclosure statement (FDS) for calendar year 2020 with the Ohio Ethics Commission.

- State elected offices
- County elected offices
- City elected offices
- School district board of education (district with more than 12,000 students)
- ESC governing board member (ESC with more than 12,000 students)

Exceptions: Candidates for the Ohio General Assembly file with the Joint Legislative Ethics Committee and candidates for judicial office file with the Ohio Board of Professional Conduct.

**The personal financial disclosure requirement is SEPARATE from a candidate’s requirement to file campaign finance reports.** You must file a financial disclosure statement regardless of whether you have raised or spent money on your campaign. It is **your** responsibility to access, complete, and file the statement by the deadline that applies to you. Any person who files the disclosure statement after the appropriate deadline is required to pay a late fee of \$10 a day for each day the statement is late. The maximum late fee is \$250.

### **CANDIDATE FILING DEADLINES:**

For most candidates\*, the statement is due **30 days before the first election** when your name appears on the ballot. For write-in candidates, the statement is due 20 days before the first election at which your candidacy will be voted upon.

**\*Incumbents:** If you will also be a candidate in 2021 for the same office or any other elected office which would require you to file a calendar year 2020 financial disclosure statement **and** are certified to a ballot prior to May 17, 2021, you are required to file 30 days (20 days for write-in candidates) before the first primary, special, or general election when your name will appear on a ballot. If you are not certified to a ballot prior to May 17, 2021 you must file by May 17, 2021.

Alternatively, blank calendar year 2020 financial disclosure statements are available for download on the Commission’s website at <http://ethics.ohio.gov>. (Calendar year 2020 statements will not be made available until January 2021.)

## Frequently Asked Questions (F.A.Q.) & Common problems with Petitions

- **When Do I Sign & Date the “Statement of Candidacy”?**: The “Statement of Candidacy” must be completed and signed **PRIOR** to circulating the petition. Any signatures signed prior to the date the candidate signed are invalid.
- **Must I complete the “Statement of Candidacy” section on each part petition?**: Yes, however you can complete these sections and photocopy it, although the original petition with the candidates original signature must be filed when the petitions are filed. This section must be completed prior to circulating the petition.
- **Where can I find term dates, Election date and the filing deadline?** : These dates are listed on the cover sheet of the petition packet. They are also available by calling our office during normal business hours.
- **Can one person sign the petition on behalf of another?**: One person may not sign a petition on behalf of another voter, even if the person signing has Power of Attorney with the exception of a process called “Attorney in Fact” that a person may file with the Board of Elections office to allow another person to sign on their behalf.
- **What if the Signature is illegible?**: The person signing the petition must sign the petition the same way their signature is on file at the Board of Elections; however, a voter can sign and print their name both in the “Signature” line to aid in identifying the voter.
- **Can a signer of the petition print their signature or use an “X” as their signature?**: The signature must match the Board of Elections records; however, a person may register with a printed signature or an “X” as their signature.
- **Can any sections be filled out by someone other than the voter on the petition signatures section?** : Yes, any field other than signature may be filled out by another person.
- **What if the County isn’t complete on the petition signature?**: If the county isn’t complete next to the petition signers signature, it will not affect the validity of the signature.

- **What if the signature dates are not sequential?:** Dates being out of order will not affect the validity of the petition or the signatures contained on it; however, signatures must be the same day or after the candidate signs the statement of candidacy.
- **If I am a partisan candidate, who can sign my petition?:** Voters who are registered in the same party or as non-affiliated voters.
- **Does the circulator have to witness each and every signature?:** Yes, a single circulator must witness each signature on a petition.
- **Who cannot sign a petition?:** Any voter who lives outside the district the candidate is running for may not sign. The circulator may not sign the petition they are circulating (although they may sign another petition passed by another circulator). Candidates may not sign any of their own petitions. Please note that the candidate still signs the “Statement of Candidacy” and the Circulator still signs the “Circulator Statement”.
- **What if the person isn’t registered or needs to update their registration?:** They can still sign as long as they update their information prior to the filing of the petitions. The circulator may collect voter registration forms and they can be filed when the petitions are filed. Any registrations filed in this manner will be processed prior to processing the petitions.
- **If the “Circulator Statement” has a different number of signatures than the number who signed, will that invalidate the part petition?:** The number of signatures in the “Circulator Statement” should be the number of signatures contained on each petition, minus any that are crossed out. If the number in the “Circulator Statement” is more than the number of signatures contained in the petition, the petition is still valid. If the number contained in the “Circulator Statement” is less than the number of signatures on the petition, the part petition is invalid.
- **Can employees of the Board of Elections check my petitions prior to filing?:** No, however the Board of Elections office has a public lookup function available online that will allow the filer to look up any voter and check their registered name and address prior to filing. Any other questions about the completeness of the petition will be directed to the information provided by the Secretary of State and the Board of Elections.
- **What is the minimum and maximum number of signatures I can file?:** Each office has a different number of required signatures, so the minimum number would be the number of required valid signatures and the maximum would be 3 times the number of required signatures. It is not recommended that you only file the minimum number of required signatures, even if you are confident that each signature is correct.
- **Can people from multiple counties sign my petition? :** If the district of the office you are filing for encompasses more than one county, a separate petition must be used for each county. All petitions, regardless of county, are filed with the most populous county and then distributed to the other counties for verification.



- **Who can circulate my petitions?** : Anyone who is over 18 years of age, a resident of Ohio and is not incarcerated or on post release control for a felony may circulate a petition. A circulator does not need to be a registered voter to pass a petition. If the candidate is running for a partisan race the circulator must also be a member of the same political party as the candidate.
- **If the candidate circulates the petition, do they still need to complete the “Circulator Statement”?** : Yes, if the circulators statement is not completed, including the signature, the petition is invalid.
- **On the Non-Partisan petition form there is a section for committee, what is this for?:**  
Since non-partisan candidates do not have a party to represent them if they are unable to run for office the candidate may appoint a “committee” to represent them and can do so by filling in the appropriate section of the petition form. This part is optional; however please note that the “Nominating Petition” section must be completed on each petition.
- **When is a term date required on a petition?:** If a candidate is running for an unexpired term the “unexpired term ending” date is always required. If a candidate is running for a full term then the “full term commencing” date is only required if the petition form has a section for “full term commencing”. If there is just a check box next to full term, checking the box is all that is required for the petition. If you do not know the term date for the office you seek, these dates are listed on the cover sheet of the petition packet. They are also available by calling our office during normal business hours.
- **If I realize I made an error on my petitions after they are filed can I make a change?:**  
Once petitions are filed they cannot be changed, supplemented or returned to the candidate. You can withdraw your petitions any time prior to the Board action of certifying your name to the ballot; and file a new set of petitions including another filing fee, any time before the filing deadline.
