

LICKING COUNTY BOARD OF ELECTIONS
PROVISIONAL MEETING
NOVEMBER 16, 2020

A special meeting of the Licking County Board of Elections was called to order at 1:50 P.M., with the following members present: Chair Grace Cherrington, Melinda Miller, Richard Salvage, and Larry Wise. Also attending were Director Brian Mead, Deputy Director Luke Burton, Assistant County Prosecutor Carolyn Carnes, Licking County Republican Party Chair Jeanie Bolton and Secretary of State Liaison Susie O'Brien.

The purpose of this meeting is to review provisional ballots ahead of the official canvass.

Provisional Ballot Review:

Deputy Director Luke Burton presented the Board with the following provisional ballots.

1941 – Voted in correct precinct, completely filled out form 12-B Provisional Ballot Affirmation without missing required information. Melinda Miller made a motion to accept the ballots. Richard Salvage provided the second. Motion carried 4-0.

145 – Registration was canceled and eligible for APRI exception under Directive 2019-23. Melinda Miller made a motion to accept the ballots. Richard Salvage provided the second. Motion carried 4-0.

29 – Ballot was the wrong precinct but correct voting location. Larry Wise made a motion to accept the ballots. Melinda Miller provided the second. Motion carried 4-0.

295 – No history of Ohio voter registration active or inactive. Ineligible for APRI exception under Directive 2019-23. Richard Salvage made a motion to reject the ballots. Melinda Miller provided the second. Motion carried 4-0.

4 – No signature on the 12-B Provisional Ballot Affirmation. Melinda Miller made a motion to reject the ballots. Richard Salvage provided the second. Motion carried 4-0.

1 – No date of birth on the 12-B Provisional Ballot Affirmation. Larry Wise made a motion to reject the ballot. Melinda Miller provided the second. Motion carried 4-0.

6 – Invalid date of birth provided on the 12-B Provisional Ballot Affirmation. Melinda Miller made a motion to reject the ballots. Richard Salvage provided the second. Motion carried 4-0.

3 – No identification provided on the 12-B Provisional Ballot Affirmation. No supplemental identification provided during the cure period. Richard Salvage made a motion to reject the ballots. Melinda Miller provided the second. Motion carried 4-0.

2 – Invalid form of identification provided on the 12-B Provisional Ballot Affirmation. Melinda Miller made a motion to reject the ballots. Richard Salvage provided the second. Motion carried 4-0.

4 – Voter home address information was left blank on the 12-B Provisional Ballot Affirmation. Larry Wise made a motion to reject the ballots. Melinda Miller provided the second. Motion carried 4-0.

10 – Invalid voter home address provided on the 12-B Provisional Ballot Affirmation. Larry Wise made a motion to reject the ballots. Melinda Miller provided the second. Motion carried 4-0.

18 – Wrong precinct and wrong polling location. Richard Salvage made a motion to reject the ballots. Melinda Miller provided the second. Motion carried 4-0.

New Business:

Richard Salvage made a motion to go into Executive Session to discuss personnel. Melinda Miller provided the second. Roll call vote: Cherrington – Yes, Miller – Yes, Salvage – Yes, Wise – Yes. Motion carried 4-0.

Adjournment and Next Meeting:


The Board's next session will take place November 18, 2020 at 10:00 A.M. for the Official Canvass.
