

# **Marion County Board of Elections**

## **Provisional and Absentee Meeting**

August 19, 2022

### **I. Call to Order**

Chair Todd Anderson called to order the Provisional and Absentee Meeting of the Board of Elections at 7:00 AM on August 19, 2022 the meeting was held in the Board of Election Office in the Marion County Building.

### **II. Attendance**

The following board members were present: Chair Todd Anderson, Brandi Downs, Lynn Zucker and Chris Smith. The Director and Deputy Director were also present.

### **III. 2022 Primary Election**

#### **Provisional Ballot Review**

The Director stated there are 2 provisional ballots from out of county. The voters are registered in other counties but didn't vote in another county. Ms. Smith made a motion to accept the ballots. Mrs. Zucker seconded the motion. The board voted unanimously to accept the motion.

The Deputy Director stated there are 3 provisional ballots with name changes. Ms. Smith made a motion to accept the 3 ballots with name changes. Mrs. Zucker seconded the motion. The board voted unanimously to accept the motion.

The Director stated there are 8 provisional ballots with address changes. Mrs. Zucker made the motion to accept the 8 provisional ballots with address changes due to moving within the county. Mrs. Downs seconded the motion. The board voted unanimously to accept the motion.

The Deputy Director stated there are 3 provisional ballots where the voters voted at the Early Vote Center and also voted on Election Day. Mrs. Downs made a motion to reject the 3 provisional ballots. Ms. Smith seconded the motion to reject the ballots. The board voted unanimously to reject these 3 ballots.

The Deputy Director stated there are 2 provisional ballots that are not registered. Ms. Smith made a motion to reject the 2 provisional ballots that are not registered. Mrs. Downs seconded the motion. The board voted unanimously to reject these 2 ballots that are not registered.

#### **Absentees**

The Director stated there are 3 absentee ballots that were received after the deadline. Ms. Smith made a motion to reject the late ballots. Mrs. Zucker seconded the motion. The board voted unanimously to reject the ballots that were received after deadline.

The Director stated there are 4 absentee ballots with issues. There are 3 absentees without the correct signature or name. There is 1 absentee without the correct I.D. They have all been sent letters. Mrs. Zucker made a motion to reject all 4 absentee ballots with issues. Ms. Smith seconded the motion. The board voted unanimously to reject the ballots with issues.


**IV. Adjournment**




