Purpose: To fix the Method, Time and Place of the 2018 General Election
Prosecuting Attorney Recount

November 6, 2019

I. Call to Order

Lynn Zucker called the Special Meeting to order at 12:10PM on November 6, 2019 in the Prospect Room in the Marion County Building.

II. Roll call

The following board members were present: Carolyn Weston, Chair Lynn Zucker and Chris Smith, along with the Director and Deputy Director (guest sign in sheet copy attached). Larry Heiser is excused.

III. Time, Method, and Place for the 2018 Recount

The Director explained the process for the recount. The recount will be held in the board of elections office. One observer per station. Chair Zucker read the list of dates and times for the recount.

The three precincts that have already been counted are 6-A, MTC, and PLC. The precincts that need to be counted are 1-C, 1-D, 1-E, 2-A, 3-C, 5-C, 6-D, NB, CV, GPC, MTD, MTE, PLA, PLE, RTA and RTB.

Ms. Smith made a motion to add the rotation sheets to the items needed for the recount. Mrs. Weston seconded the motion. The board voted unanimously to accept the motion.

Mrs. Weston made a motion to accept the recount time and dates. Ms. Smith seconded the motion. The board voted unanimously to accept the motion.

Ms. Smith made a motion to open the recount on November 12, 2019 in the outer office then move to the work room. Mrs. Weston seconded the motion. The board voted unanimously to accept the motion.

The board voted unanimously to call the question.

Ms. Smith made a motion to report to the Grogan Campaign and to the Ratliff Campaign each day by email each day after the recount. Mrs. Weston seconded the motion. The board voted unanimously to accept the motion.

IV. Adjournment


Mrs. Weston made a motion to adjourn. Ms. Smith seconded the motion. Chair Lynn Zucker adjourned the meeting at 1:08PM.






