for the purpose of CONSTRUCTING, FURNISHING AND EQUIPPING (A) A FIREPROOF HIGH SCHOOL BUILDING, INCLUDING SITE IMPROVEMENTS, WATER AND SEWAGE FACILITIES, AND (B) A FIREPROOF ELEMENTARY SCHOOL BUILDING, INCLUDING SITE ACQUISITION AND IMPROVEMENTS AND WATER AND SEWAGE FACILITIES, AND PROVIDING FOR IMPROVEMENTS REQUIRED TO CONVERT AN EXISTING FIRE-PROOF HIGH SCHOOL BUILDING TO ELEMENTARY SCHOOL USE

and an additional Tax of .5 mill for the purpose of paying the cost of the purchase of classroom facilities from the state for no longer than 23 years

in the sum of \$780,000.00

and a levy of taxes be made outside of the ten mill limitation estimated by the County Auditor to average 5.30 mills for each one dollar of valuation, which amounts to
