Notice is hereby given that in pursuance of a Resolution of the Trustees of Jackson Township, of Van Wert County, Ohio, passed on the 20th day of December, 2021, there will be submitted to a vote of the people at the Primary Election to be held at the regular places of voting on Tuesday, the 3rd day of May, 2022, the question of levying a tax, in excess of the ten mill limitation for the benefit of Jackson Township for the purpose of fire and EMS services. Notice of Election on Issue of Bonds

Notice is hereby given that in pursuance of a Resolution of the Board of Education of the Van Wert City School District, Van Wert County, Ohio, passed on the 12th day of January, 2022, there will be submitted to a vote of the people at the Primary Election to be held at the regular places of voting on Tuesday, the 3rd day of May, 2022 the question of issuing bonds in the principal amount of five million dollars (\$5,000,000) for the purpose of constructing and renovating athletic facilities additions and improvements, together with equipment, site improvements, and all appurtenances thereto. The maximum number of years over which the principal of the bonds may be paid is 20 years. The estimated additional average annual property tax levy amounts to \$0.115 for each one hundred dollars of tax valuation, which is 1.15 mills for each one dollar of valuation, in excess of the tax limitation as estimated and certified by the County Auditor. The first calendar year in which the tax is expected to be due is 2023. The polls for the election will be open 6:30 a.m. and remain open until 7:30 p.m. on election day.
